To the Inhabitants of the Town of Epsom in the County of Merrimack, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House, in said Epsom, on Tuesday, the eighth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for same.
- 3. To see if the Town will vote to accept the report of the Cemetery Trustees and appropriate the sum of \$600.00 for the purchase of 60 lots, at \$10.00 per lot, for the proper enlargement of McClary Cemetery.
- 4. To see if the Town will vote to accept the provisions of Chapter 87, Sec. 1, of the Revised Statutes, on a section of the Suncook Valley road, so called, and appropriate, or set aside from the amount raised for highway work the sum of \$500.00 for this purpose.
- 5. To see if the Town will raise and appropriate the sum of \$800.00 for State Aid Maintenance, the State to give \$1,200.00.
- 6. To see if the Town will raise and appropriate the sum of \$1,256.00 for Trunk Line Maintenance, the State to give \$4,082.00.

- 7. To see if the Town will vote to accept the Tractor and Snow Plow now on trial by the Town, and raise by long term note the balance of the purchase price (\$3,500).
- 8. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for construction of a section of the Suncook Valley Road, so called, the State to give \$5,000.00. Said construction to be a continuation of the 1926 project.
- 9. To see if the Town will raise and appropriate the sum of \$160.00 for the Library as requested by the Library Trustees.
- 10. To see if the Town will raise and appropriate a sum of money for the celebration of Memorial Day.
- 11. To see if the Town will raise and appropriate the sum of \$400.00 for White Pine Blister Rust control.
- 12. To see if the Town will vote to make the Mountain Road, so called, running from Mt. McCoy Cottage to the lane leading to the old Brackett place, now the George N. Brown place, subject to gates and bars.
- 13. To see if the Town will vote to accept the report of the committee on the 200th anniversary celebration of the Town and raise and appropriate the necessary money for the same.
- 14. To see if the Town will vote to authorize the Library and Cemetery Trustees to accept certain gifts and bequests, in the name of the Town, to our Library and Cemetery from the Hall Estate.
- 15. To see if the Town will vote to accept the Roscoe Hill Trust Fund of \$100.00 for the care of burial lot.

- 16. To see if the Town will vote to allow a discount of 3% on all Taxes paid on or before July first.
- 17. To transact any other business that may legally come before said meeting.

SCHOOL REPORT

REPORT OF SCHOOL BOARD

To the Citizens of Epsom:

We herewith present our annual report including the financial record for the school year ending June 30, 1926.

In accordance with the sentiment expressed at the last district meeting the North Road and Mountain school buildings have been put in condition suitable for maintaining schools there. We are employing seven teachers this year.

The problem of the small one-room school is one with which we are at present greatly concerned. It is a question in the minds of many whether the advantages gained by attending a consolidated school are not more than offset by the disadvantages incident to transportation, long days, etc. Especially is this feeling strongest in regard to small children in the lower grades. Naturally there is a heavy expense per capita in maintaining a small school of less than ten pupils. Nor is this expense likely to be less in future years. It is the aim of the State Department of Education to be able eventually to provide Normal trained teachers for all schools. This means, of course, that salaries will be greater than now when some of our teachers have only summer school training. Our town is composed largely of rural communities and there is a strong feeling that to close a school in a locality renders that part of the town less desirable to live in and the valuation of property there lower.

Some towns attempt to solve this problem by holding schools where there are the greatest number of pupils or where transportation to another school would cause the greatest inconvenience, changing such schools as conditions may warrant but not keeping many rural schools open any one year.

Another plan is to transport largely through the greater part of the year and to maintain the rural neighborhood school for a few weeks during the winter. A teacher for this short period might be a Normal School student doing practice teaching.

Some interesting statistics in regard to rural schools are included in the report of the Superintendent of Schools.

Our local Red Cross branch has enabled the District to receive the benefits of a public health nurse for approximately half of the last school year and for all of the current year. Detailed information regarding Miss O'Donnell's work will be found in her report on another page.

We thank the parents and citizens for your co-operation and loyal support.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens:

I herewith submit my seventh annual report of the schools of Epsom.

There were maintained during the year, five schools for a school year of 36 weeks, with no change in the teaching force.

The total school enrollment was 89 (46 boys and 43 girls), with a daily average attendance of 92.68 per cent.

The schools were in session on an average 349.80 half days.

I quote somewhat freely from the Report of the State Board of Education for the Biennial Period, ending June 30, 1926, for the purpose that citizens and parents may more fully understand the duties which they are to perform in the making of good schools.

"School Year

"When the 1919 school law was enacted, no feature seemed more chimerical to school board members and others familiar with New Hampshire country life than the standard that all children should have schools for at least 36 weeks each year. It was believed that for all time farm children, because of difficulties of travel and weather, must have less schooling than their urban cousins. It was held that farm children could not be spared from home duties, that roads were impassable and that weather conditions were beyond control. Accordingly the law provided that on petition, the State Board of Education for unusual circumstances, might shorten the school year for specified schools.

"In one respect the record for 1925 was not a satisfactory one. In a number of towns there were scattered

cases of scarlet fever in the Spring months. This resulted in a degree of panic in some places and closed schools. In others, the school boards and health officers were wiser. Schools were kept open, all pupils watched carefully for the isolation of incipient cases and the disease promptly stamped out.

"In 1926 school boards consistently refused to be stampeded by contagious diseases and every school in the state was open for the full year.

"A plan which is gaining approval among school boards is to contract for 360 half-days of service in thirty-seven working weeks. By this plan, every day lost for any cause may be made up. Some of our school boards, through carelessness, are permitting many half-days each year to be lost."

"School Attendance

The New Hampshire school attendance law is very simple. All children must attend a public or an approved private school every day that the school is in session from their eighth to sixteenth birthdays, or to their fourteenth birthday if they have then completed the eighth grade. There is no excuse except physical or mental incompetence. Neither poverty of the parents nor isolation of the home may stand in the way. At least eight years of schooling is an inalienable right of New Hampshire children.

"For thirty years this law has been unchanged and has been enforced. For this purpose, each district has its own truant officer. Commonly these men are vigilant and effective. The cities are particularly well served. In the small towns often difficulties arise due to the fact that the truant officer and the negligent parent are neighbors or relatives and an official act is likely to be regarded as a personal one. For this reason we have many calls for aid from a state attendance officer."

"Cost of Instruction in Schools

"This table gives the average cost per pupil for instruction in elementary schools of the three types. The salary of the teacher is the only item of instruction considered. The teachers in the rural schools are the lowest paid but the small size of the school makes the per pupil cost very high. It is even higher than in city schools where teachers may receive double the salary.

"Experience shows that with fewer than 10 pupils a satisfactory school can seldom be maintained, and for the best work a school should enroll at least 15. Yet 100 schools number fewer than 10 and 150 more fewer than 13. Nearly all of these are rural schools. Business economy and educational efficiency require for these schools the consideration of transportation rather than local school maintenance. On the other hand a one-room rural school which enrolls 25 pupils or over needs a particularly competent teacher or division, with the transportation of upper grades to another school. One-room schools are expensive. We believe, however, that they should be maintained when sufficient children can be gathered to make a real school.

"In any attempt to reduce the cost of schools, attention should be given to the very small schools. It is evident that in a school of six pupils the per pupil cost of maintenance alone will average \$120.00."

Health

Health inspection was conducted by Miss Katherine A. O'Donnell, R. N., of Manchester, N. H. Miss O'Donnell was efficient and enthusiastic in her work and through her

work in the school and home taught the pupils to practice better health habits. In Miss O'Donnell's report you will find her work in detail.

I believe it is generally acknowledged that no problem of school management is of more importance than the care of conditions affecting the physical welfare and health of the pupils.

Teachers' Meetings

At these meetings able and instructive addresses were given by Dr. E. W. Butterfield, Commissioner of Education, "A Worthy Use of Leisure Time"; Headmaster Harold M. Smith of Pembroke Academy, "English"; Miss Phila Griffin, State Agent for Rural Schools of New Hampshire, "History"; Miss Bernice Batchelder, Former Instructor in Bridgewater (Mass.) Normal School, "Geography"; William Y. Morrison, State Agent for High Schools of New Hampshire, "The Development of Teachers," and Louis P. Benezet, Superintendent of Schools of Manchester, "Reading."

At other meetings the subject of Economy was discussed as shown in the use of a daily time-table of recitations, in the distribution of scholars' supplies, and in the care and use of text-books.

These meetings serve a useful purpose in keeping alive a professional spirit and in improvement in school management and methods.

Various standardized tests were given throughout the year with emphasis placed upon the fundamental processes in Arithmetic.

The teachers were faithful and efficient and improved their work through attendance at Summer schools, teachers' institutes, and by reading books and magazines on education. Parents and citizens are cordially invited to visit the schools frequently.

In conclusion I express my appreciation for your cooperation and assistance.

REPORT OF SCHOOL NURSE

Mr. Henry S. Roberts, Superintendent of Schools:

Dear Sir:

In my visits to the schools I examined the pupils for defects of eye, ear, teeth, throat and lungs and when found I notified the parents by cards. I also visited the homes to assist the parents in correcting these defects, suggesting remedies and other remedial aid.

I placed upon the walls dental charts and cards of health rules, and with the teachers encouraged contests to see which pupil would practice the greatest number of these rules. Each child's name was enrolled on a chart and a star placed after the name of the child performing the required tasks. The greatest number of stars indicated the winner.

The children were measured and weighed to ascertain if they were up to standard in height and weight; if they were found to be under-weight they were instructed as to diet and health habits. The following visits and corrections have been made:
