You are hereby notified to meet at Town Hall in said Epsom, on Tuesday, the ninth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same in accordance with House Bill No. 234, as passed by the Legislature of 1935 and as submitted by the Budget Committee.
 - 3. Is it expedient to revise the Constitution?
- 4. To see if the town will vote to discontinue the North East Road, so-called, leading from Northwood to Pittsfield.
- 5. To see if the town will vote to allow a discount of two per cent on all property taxes paid previous to July 1, 1937.
- 6. To see if the town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes.

7. To transact any other business that may legally be brought before said meeting.

ANNUAL REPORT OF THE TRUSTEES OF THE EPSOM PUBLIC LIBRARY

The Trustees are pleased to state that during the year the library has been shingled and the cement walk completed. The Selectmen have kindly promised to cooperate in arranging a driveway and parking space at one side of the building and it is hoped the shrubbery and lawn will be completed this year.

Early in the year Mrs. Laura Y. Bickford tendered her resignation as librarian after several years of faithful, efficient service. She was induced to accept a leave of absence to December 1st. At a meeting of the Trustees in December Mrs. Bickford appeared and stated that she could not possibly continue so her resignation was accepted.

Miss Hester Bickford, who has had library training and experience, was appointed to fill the vacancy.

During the years Mrs. Bickford has been librarian she has kept the library up-to-date, has attended the Library Association and Conferences at her own expense, established a card system, called at the State Library in Concord to exchange many books that were wanted here in Epsom, and given of her time freely in many ways. During this last year when funds were available from the Federal Government to benefit libraries, she has supervised the mounting of hundreds of pictures on cards that will be of great assistance to those studying birds, animals, minerals, history, geography, etc. These pictures are now available at the library.

It is with regret that we see Mrs. Bickford giving up her activities in the library and the Trustees have passed a vote of thanks and appreciation for all she has accomplished.

It is hoped that a way may be found this year to have the library open two or three hours Saturday evenings during the summer in addition to Saturday afternoon.

The New Rye Branch is co-operating with frequent changes of books so that reading matter is available to all parts of the town during the year.

The circulation for the year has been 5,770 volumes, of which 2,020 volumes were from the branch at New Rye.

Postal card notices have been sent to persons interested in special subjects. Reserve cards have been kept. Leading events in current news have been noticed by appropriate exhibits of books and pictures displayed in the library.

The librarian and assistant librarian attended the meetings of the New Hampshire Library Association, held at Colby Junior College, New London, in September.

Early in February, through the interest of the N. H. Public Library Commission and the National Youth

Administration, the library was offered the services of an N. Y. A. worker. Miss Beatrice Carter was the only eligible youth in the town available for work.

It had long been the ambition of the trustees to have a picture collection in the library, and with this in mind, duplicate copies of the National Geographic Magazine had been collected and filed away for future use. It was decided to use the picture collection for the N. Y. A. project. Miss Carter was given instruction in cutting and mounting pictures. She began work February 26, working 46 hours a month with a compensation of \$19.00. The work was carried on in Miss Carter's home.

Miss Carter completed the picture work in December, having made 70 picture sets, containing approximately 3,000 pictures. These sets have been catalogued and placed on the library shelves for use by the school children, or anyone interested in picture collections.

The only expense to the library for this N. Y. A. work has been the cardboard and paste used in mounting the pictures, costing approximately 60 cents per month. The project has been supervised by the librarian. Time report sheets have been made out every two weeks and sent to N. Y. A. headquarters.

Miss Carter has developed skill in her work and her services are greatly appreciated. She will continue with a new type of work beginning January 1, 1937, that of binding and mending worn books. Miss Carter is now working 60 hours per month with a compensation of \$21.00.

The library work has gone on in excellent order and the librarian desires to make public recognition of the ready and willing and efficient service given by the substitute librarian, Miss Hester Bickford, during the librarian's leave of absence. To the the members of the Board of Trustees, the librarian returns grateful acknowledgment for council and interest in the various forms of library activities during the past eight years.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of Epsom:

This year education has looked to its foundations. Three hundred years ago, Harvard College was established. In "New England's First Fruits," the Puritan historian says,

"After God had carried us safe to New-England and wee had builded our houses, provided necessaries for our livli-hood, rear'd convenient places for Gods worship and settled the Civil Government, One of the next things we longed for, and looked after was to advance Learning and perpetuate it to Posterity. . ."

One hundred years ago, Horace Mann dedicated himself to the welfare of children and the free common school, which he called "the greatest discovery ever made by man." As first Secretary of the Massachusetts State Board of Education, he founded the first Normal School in America, designated by him as "a new instrumentality in the advancement of the human race." He raised the child, the teacher, and the educational enterprise to a new dignity, saying, "In our country, and in our times, no man is worthy the honored name of a statesman, who does not include the highest practicable education of the people in all his plans of administration." At his last commencement as President of Antioch College, he left this message: "Be ashamed to die until you have won some victory for humanity."

This is also the Centennial year of William Holmes Me-Guffey, editor of the famous series of readers bearing his name. Like the New England Primer of Colonial days, his readers aimed to edify the young in lofty moral ideals. With true scientific instinct, he experimented with his selections upon actual classes before final publication. Animals (The Lion, The Lame Dog, The Arab and his Horse), Indians (Logan, Chief of the Mingoes; The Lone Indian), bad boys (Lazy Ned, and others "mischievous" or "passionate," and even Meddlesome Matty), as well as truthful George, industrious Mary Dow, and the Just Judge, are still vividly remembered by citizens of an older school generation.

In McGuffey's day, "The Dunce" still survived, a "sad, sad sight," branded, humiliated, condemned, whom "no one loves." Knowledge of child nature and the workings of the human mind in general have progressed far since that time, or rather returned closer to the source of Charity. Now we seek the origins of behavior in diffi-. culties that can often be removed by remedial treatment in reading and other school subjects, as well as intelligent provision for normal activities in home and community. In Epsom, one of the most modern and scientific reading systems was installed in the lower grades this year. This will be gradually extended. Teachers have been furnished with special reference books and materials in remedial reading, and the special help of experts has been sought in individual cases. It is our aim to transfer some of the burden from the weak to the strong. These efforts are already showing a measure of success.

The adequacy of our school buildings can help in this improvement. All four buildings now in use have been wired for electricity through the kindness of the Parent-Teacher Association, the Community Club, and other interested citizens. Short Falls and Center Hill school-houses both have space within the building for septic

toilets. At least one of these should be installed during the coming year.

I submit the following report of the Epsom Volunteer Fire Department. Another year of progress has been made by the members. We have increased our membership and most members are present at each meeting. There have been twelve regular monthly meetings. We have had but one serious fire, while the others were chimney or minor fires. Our alarm system by telephone has worked out well, and the men respond faithfully.

With the co-operation of the Chichester Department we sponsored a winter carnival which added materially to our funds. We have bought necessary equipment again this year.

There is a great need for a portable pump for use outside of hydrant service. I would recommend before another year that a portable pump should be purchased. Money for this should be raised by the town.

During a serious fire in Chichester, we co-operated, using our apparatus, making a total of 14 calls made during this year.
