ROBERT EDWARD BARTLETT

Robert Edward Bartlett was born in Concord, N. H. on January 17, 1930 and became a resident of Epsom in 1932. He was educated in town schools and graduated from Pembroke Academy. Active in town affairs, he was Supervisor of the Check List and Road Agent, District No. 1. The school bus business and the R. E. Bartlett Construction Company was operated by him for many years. He was a member of the Epsom Baptist Church and all Masonic bodies.

His family includes his wife Myrna, a son William and two daughters, Linda and Allyson.

In August 1970 he was named Citizen of the Year and he died on September 10, 1970.



RALPH S. CARR

He was born in Concord, and was a postal supervisor 40 years. He was a member of the Retired Postal Workers of America.

Mr. Carr served the town as representative to the legislature one term, and was a delegate to the Constitutional Convention. He was treasurer of the Epsom Water Precinct.

His fraternal affiliations in Concord included Blazing Star Masonic Lodge, of which he was a 50-year member, the N. H. Consistory, the Scottish Rite bodies and Bek-tash Temple, Shrine.

He leaves his widow, Mrs. Ruth (Matott) Carr; two sons, Ralph S. Carr, Jr. of East Greenwich, R. I., and Collins F. Carr of Concord; a daughter, Mrs. Ruby Kenniston of Chicago; seven grandchildren, three great-grandchildren, and nieces and nephews.




HERBERT R. SELDON

Born in Pittsfield, N. H. on June 21, 1901. He was the son of John B. and Hattie N. (Young) Seldon. On July 8, 1938, he was united in marriage with Annie M. Bragg of Lower Gilmanton, N. H.

He was a member of the Pleiades Eastern Star Chapter of Pittsfield and was a member and Past Master of the Corinthian Masonic Lodge No. 82 of Pittsfield, N. H. He also served as Chaplain of the lodge for several years and was a member of the N. H. Consistory of 32nd Degree Masons, Valley of Nashua.

He was the owner and operator of the Gossville General Store for about 10 years. He became Acting Postmaster of the Gossville Post Office in June of 1957 and became Postmaster in Sept. of that year, a position he held until his death in 1970.

He served the Town of Epsom as Chairman of the Budget Committee for several years and was active in town projects. Mr. Seldon died at the Concord Hospital on August 1, 1970.

GEORGE H. YEATON

George H. Yeaton, son of James and Annie R. (Crockett) Yeaton, was born in Epsom on December 21, 1883. He was a lifelong resident of the town. He attended the New Orchard Road School and Coe's Academy in Northwood. On June 1, 1909, he married Ada L. Brown, a native of Gilmanton. For fifteen years he was postmaster at Gossville and had worked as a farmer, lumberman and dairyman.

Mr. Yeaton was a member of the Baptist Church for 61 years and served as trustee, treasurer and deacon.

A charter member of the Fire Department, he later became an honorary member. He was a charter member of the Gossville Junior Order of United American Mechanics and had been a member of Evergreen Odd Fellows Lodge for 55 years.

Mr. Yeaton was selectman here for sixteen years, served one term as tax collector, and was health officer three years, town road agent three years, and a former justice of the peace.

He was foreman for the N. H. Forestry Department in building the Belknap Mountain Road in Gilford. He had been in charge of early state road construction in Epsom.

He played in the Brass Band in Epsom, serving as band treasurer, and also played in the Mechanic's Band and Northwood Band.

Mr. Yeaton was chosen Epsom Citizen of the Year in 1964. In later years he compiled much town history and recorded memories of townspeople.

On February 1, 1970, at the age of 86, Mr. Yeaton died at his home after a long illness.

TOWN WARRANT
The State of New Hampshire

To the Inhabitants of the Town of Epsom in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Epsom on Tuesday, the 9th day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To see what action the Town will take upon the Budget submitted by the Budget Committee.
3. To see if the Town will raise and appropriate the sum of \$1,045.02 for the maintenance, construction, or reconstruction of Class V Highways, the State to contribute \$6,966.77 as provided in Chapter 83 Laws of 1953.
4. To see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes.
5. Pursuant to the Provisions of the Laws as revised, Chapter 292, Section 7, 1949. The following Article is submitted: Shall the Provisions of Chapter 171-A of the revised Laws relative to playing games of Beano be adopted in this Town?

6. To see if the Town will vote to raise and appropriate the sum of \$632.00 for the Concord Hospital to help offset the estimated deficit for the year 1970. (Recommended in the Budget)

7. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the Barnstead Ambulance Fund. (Recommended in the Budget)

8. To see if the Town will vote to raise and appropriate the sum of \$300.00 to be used in the White Pine Blister Rust Control Program. (Recommended in the Budget)

9. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 to be put in a Capital Reserve Fund in anticipation of improvements to the Epsom Public Library. (Recommended in the Budget)

10. To see if the Town will vote to raise and appropriate the sum of \$5,000.00 to be put in Capital Reserve Fund for the purpose of a Town Dump (Sanitary Land Fill Project, or an incinerator.) (Recommended in the Budget)

11. To see if the Town will vote to have all real estate in the Town of Epsom reevaluated by the New Hampshire State Tax Commission and to raise and appropriate the sum of \$6,000.00 in 1971, and \$6,000.00 in 1972, to complete payment for this purpose. (By petition)

12. To see if the Town will vote to accept as a Town Road — Oak Road, so called, located in Northwood Lake Development, adjacent to Route No. 4. Money for improvements of said road included in Highway Budget Funds. (By petition)

13. To see if the Town will vote to authorize the Selectmen to negotiate for, take an option on, or purchase the necessary land to be used as a Town Dump and to raise and appropriate the sum of \$2,500.00 for this purpose. (Recommended in the Budget)

14. To transact any other business that may legally be brought before this meeting.

(Polls will not close earlier than 6:00 P.M.)

LIBRARIAN'S REPORT

The Epsom Public Library circulated over 7000 books during the year, with many high school children using the reference room, persons using the books for town histories and genealogies.

Miss Anita Fife and Mrs. Gertrude Stevens have been on hand to help keep the library running smoothly throughout the year.

Many books have been given to the library at various times for use in the library or to be used or disposed of at the discretion of the librarian.

The Bookmobile has been at the library three times during the past year and a selection has been chosen for supplement to the books in the library.

Another generous donation of records has been received from RCA and a donation from Columbia Records this year. These have been catalogued and are ready for circulation at this time.

The Shut-in service has continued throughout the year, headed by Mrs. Ellen Eppelsheimer and books are taken to shut-ins once very month or so. Anyone wishing to use this service may contact the librarian and arrangements will be made.

There are many magazines for circulation and at this time we receive about 25 subscriptions, many of them being gift subscriptions from friends of the library.

During the early spring, some gravel was hauled and the mud problem was eliminated this past spring.

The shelves are crowded and books are just inadequately displayed for the use of the patrons, especially the children's books. At this point the circulation and usage of the library has outgrown the size of the library. Because of the increase usage of the reference room, it has been hard to fit in a story hour.

Three books have been donated by the Epsom Woman's Club in memory of departed members — Mrs. Edith Piper, Mrs. Doris Crosbie and Mrs. Pauline Dole — *Plenty of Sea Room*, *Mr. Daniels and the Grange*, and *Second Barrel*. Gibson Book Store donated a book entitled *A Short History of the Mail Service* in memory of Mr. Ralph Car.

The Library Trustees and the Librarian wish to thank all that have helped during the past year to make this a successful year. Any suggestions for the betterment of the library would be welcomed by you the public.

Both state and towns are striving to meet this challenges. Results show that we are not doing enough, we must do more in the matter of fire prevention education, a more active inspection program and a more prompt, complete investigation of fires where definite cause is not known with court action where the need is indicated.

We must insist that minor children are given needed supervision, this is a parent's responsibility.

Your Warden and District Chief stand ready to help in this work.

Our gratitude to all who have helped in forest fire prevention and suppression this past year and we look forward to this continued help in our effort to improve our good prompt detection system and fast suppression action. This, coupled with a good prevention program, will improve our fire record.

Follow these simple suggestions to help.

Set a good example for others by observing fire permit laws and regulations; take your debris and waste to the town dump; keep matches away from children and be sure your smoking material is dead out when discarded.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Having been your Superintendent for a very short time I am unable to report on past accomplishments but will offer some observations on what appear to be most pressing problems and suggest some alternative solutions.

Housing is the most urgent problem in most Districts. We should closely examine new methods of construction, such as pre-fabricated and pre-engineered buildings, concrete slab buildings and portable classrooms and compare them with the more traditionally constructed schools.

Curriculum revision must be constant. Our schools must place more emphasis on those pupils who complete their formal education in the public schools. Study and evaluation can show which courses are relevant to the 1970's and which should be scrapped or changed.

The structure of the school must be scrutinized as to its effectiveness in each area. Campus type schools, open concept schools, team teaching, mini-courses of short duration, humanities approach and other innovations can bring education alive to the disinterested child.

By 1973, State minimum standards must be met by all schools in the State. They are too long to reproduce here however several copies are available at the Superintendent's office for loan.

The School Department appreciates your fine support of the schools.

The Library has continued to operate with volunteer librarians. Mrs. Robert Forrester has contributed much of her time and energy to organizing the volunteer assistants and setting up the library system. We appreciate her efforts, and those of the volunteers, for making the continued operation of the library possible.

With the increasing enrollment, space is becoming an increasingly serious problem. If the present rate of increase continues, all available classrooms will be in use, and we may be forced to discontinue our library, typing and kindergarten programs.

SCHOOL HEALTH REPORT

To the Superintendent of Schools:

The health program for the year 1969-1970 was carried out in the usual manner with an annual physical inspection of each student by the nurse. When defects were noted, the appropriate referral and follow-up were made.

The students again received the benefit of preventive dental care through programs sponsored by the New Hampshire Bureau of Dental Public Health. One-hundred and forty children responded to the cleaning and flouride clinic held in the Spring, sponsored by the P.T.O.

The Heaf test for Tuberculosis was offered in school to the students in the first and seventh grades. A total of sixty-two children were tested.

A series of three Immunization Clinics, sponsored by the Epsom Woman's Club, were held in March, April and May. A total of three-hundred and thirty-six doses of vaccine were administered by Dr. Patrick Kelly, Pittsfield. Mrs. Margaret Findlay and Mrs. Evelyn Johnson, members of the Woman's Club, and Mrs. Jacqueline Palmer R.N., generously offered their services at these clinics and their help was greatly appreciated.

Rubella (German Measles) immunizations were especially encouraged this year. One-hundred and thirty students received this vaccine at clinics held in January and March.

Twenty-five children were registered for school entry at a pre-school clinic in May.

First aid was administered to approximately forty-eight students, and twelve home visits were made by the school nurse.

The following films were shown in conjunction with the health program for the year.

Two drugs and narcotics films

Two personal health films for girls

I would like to express my thanks to Mrs. Dorothy Wells for the help and guidance she has given me this past year. Mrs. Wells resigned as school nurse the first of December and we greatly appreciate her concern and efforts on behalf of the school children and residents of Epsom. Thank you, too, to Mr. Martineau, Mr. Morgan, School Board Members, teachers and parents for their cooperation and support during the past year.
