TOWN MEETING MINUTES

March 16, 1985, opened at 9:30 A.M. by Paul Martell.

George Wiggin made a motion to pass over article 2 until after article 16. The motion was seconded by Shirley Parker and passed in the affirmative.

- Article 3: To see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes. Hans Wendler made a motion to accept the article as read and it was seconded by Tom Lalish. The article passed in the affirmative.
- Article 4: To see if the Town will vote to raise and appropriate the sum of \$10,847.00 for the Barnstead Ambulance Fund. Linda Sawyer made a motion to accept the article as read and it was seconded by Shirley Parker. The article passed in the affirmative.
- Article 5: To see if the Town will vote to raise and appropriate the sum of \$1,276.00 for the continuation of services to the low income residents of Epsom, through the Suncook area center of the Community Action Program, Belknap Merrimack Counties, Inc. Hans Wendler made a motion to accept the article as read and it was seconded by Gloria Reeves. The article passed in the affirmative.
- Article 6: To see if the Town will vote to discontinue the Fifteen Hundred Dollar (\$1500.00) Fund for building a ramp for the handicapped and return the \$1500.00 Revenue Sharing money to the Revenue Sharing Fund. George Gantz made a motion to accept the article as read and it was seconded by Kevin Reeves. Audrey Ellis made an amendment: To continue the fund and that a temporary ramp be constructed within six months. This amendment was seconded by David Diamon. There was a call for a show of hands and the count was: yes-36, no-44. The amendment was defeated. Article six was defeated.
- Article 7: To see if the Town will vote to appropriate and authorize the withdrawal from the Federal Revenue Sharing Fund for use as set-offs against budgeted appropriation for the following specific purposes and in the amounts indicated herewith or take any other action hereon:

\$1,000.00 added to the Fund for painting the Town Hall for a total of \$2,500.00

\$35,000.00 for Summer Maintenance

Up to \$13,155.00, if available, for the Library

Harvey Harkness made a motion to accept Article 7 as read and it was seconded by George Gantz. The article passed in the affirmative.

Article 8: To see if the Town will vote to authorize the Board of Selectmen to apply for, accept and expend money from state, federal or another government unit or a private source which becomes available during the year in accordance with the procedure set forth in RSA 31: 95-b. Paul Lavoie made a motion to accept the article as read and it was seconded by Dan Hyde. The article passed in the affirmative.

Article 9: To see if the Town will vote to have the one (1) year term of the Treasurer increased to a three (3) year term. Eleanor Anderson made a motion to accept the article as read and it was seconded by Hans Wendler. The article was defeated.

Article 10: To see if the Town will vote to have the three (3) year term of the Road Agent reduced to a one (1) year term. By Petition. Kevin Reeves made a motion to accept the article as read and it was seconded by Gloria Reeves. George Gantz made a motion to amend: At the end of the current road agents term, the selectmen will assume the responsibility for appointing the road agent. The amendment was seconded by Harvey Harkness. George Gantz withdrew his amendment. Article 10 passed in the affirmative.

Article II: To see if the Town will vote the following: PROPERTY TAX LIMITATION - Under no circumstances shall any property tax bill exceed 2% (\$20 per thousand) of the fair market value of the property being taxed. By Petition. Not Recommended by the Budget Committee. John Kelleher made a motion to accept the article as read and it was seconded by Hans Wendler. John Kelleher made a motion to amend: Effective December 31, 1985, under no circumstances shall any property tax bill issued by the Town of Epsom exceed 2.3% (\$23 per thousand) of the fair market value of the property being taxed. The amendment was defeated. The article was defeated. The amendment was seconded by Kevin Reeves.

Article 12: To see if the Town will vote the following: User Fees - Henceforth, The Board of Selectmen shall be allowed to charge reasonable "user fees" wherever deemed appropriate to do so. By Petition. Hans Wendler made a motion to accept the article as read and it was seconded by John Kelleher. The article was defeated.

Article13: To see if the Town will vote to appropriate and authorize withdrawal from the Conservation Fund (RSA 36:4 - 36:5) the sum of Three Hundred Dollars (\$300.00) to be used for the 1985 budgetary operating expense. By Petition. Hans Wendler made a motion to accept the article as read and it was seconded by Greg Hurd. The article passed in the affirmative and it is to be noted that it was not unanimous.

Article 14: To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000.00) to continue the Concord Regional Visiting Nurse Association program for the purpose of providing nursing and therapeutic services at the home, and other health programs through clinics to all residents of the Town of Epsom. By Petition. Recommended by the Budget Committee. Harvey Harkness made a motion to accept the article as read and it was seconded by James Wells. The article passed in the affirmative.

Article 15: To see if the Town will vote to raise, appropriate and expend Fifteen Hundred Dollars (\$1,500.00) for professional assessors for the 1985 tax year. Approved by the Budget Committee. George Gantz made a motion to accept the article as read and it was seconded by Shirley Parker. The article passed in the affirmative.

Article 16: To see if the Town will vote to withdraw from the Computer Gift Fund the sum of \$3,500.00 to cover service contract and supplies. Frank Duszczak made a motion to accept the article as read and it was seconded by Hans Wendler. The article passed in the affirmative.

Article 2: To see what action the Town will take upon the budget submitted by the Budget Committee. George Gantz made a motion to accept the article as read and it was seconded by Hans Wendler.

George Wiggin made a motion to restore \$3,000.00 to the Insurance line item. The motion was seconded by Audrey Ellis. The motion passed in the affirmative.

George Wiggin made a motion to restore \$5,000.00 to the interest expense line. The motion was seconded by Judy Todd. The line would now read \$15,000.00. The amendment was defeated.

Gary Matteson made a motion to amend the police department budget line item to add \$7,300.00. The line would now read \$48,800.00. The motion was seconded by David Noyes. The amendment passed in the affirmative.

Article 2 passed as amended and the bottom line of the budget is \$464,765.53.

Article 17: To see if the Town will vote for the rubbish container ordinance, as follows: It shall be unlawful for any dumpster or other commercial container designed for the collection of refuse or garbage in an area designed for multi-family occupance (Mobil Home parks, Campgrounds, and apartment houses, etc.) to be placed within fifty (50) feet of any occupied unit of housing, camping site, or other occupied structure. The individual homeowned rubbish cans must be emptied at least every other day, except Sunday, after which they will be emptied the immediate day following. Judy Todd made a motion to accept the article as read and it was seconded by Frank Duszczak. George Wiggin made a motion to amend the article to delete the last

sentence of the article. It was seconded by Norm Birch. The amendment passed in the affirmative. George Wiggin made a motion to amend the article with a new last sentence. The Individual home-owned rubbish cans in the above designated areas must be emptied at least, every other day, except Sunday, after which they will be emptied the immediate day following. The amendment was seconded by Hans Wendler and it passed in the affirmative. Article 17 passed in the affirmative as amended.

Article 18: To transact any other business that may legally be brought before this meeting. Neil English addressed the proposed Route 393.

Dr. Samuel Clark spoke of George Wiggin's nine years of faithful, dedicated service to the Town and he received a rising vote of thanks for his contribution to the community.

John Sawyer, Fire Chief wished to thank those who have supported the fire department and announced that the old truck will need to be replaced soon.

S.C.O.P.E Update read by the moderator.

Bev Miner made a motion to adjourn at 12:31 and it was seconded by Connie Pitcher.

The Trustees appreciate that the well being of the library is due to the dedicated and quality work of the Librarian, Nancy Claris, and to the generous services of the many volunteers who are currently supplying 6 to 10 hours a week in office staff work as well as some maintenance and repair work.

EPSOM' RESCUE SQUAD

1985 has been a very busy and productive year for the Epsom Rescue Squad. Active membership, both in numbers of members and in level of activity has been at an all time high. The new members who joined the squad in the fall of 1984 have contributed greatly and integrated very well with the other members of the squad.

The rescue squad provided medical assistance at 132 calls in 1985, including automobile accidents and other medical emergencies. We continue to be a first response organization which works inconjunction with local ambulance services. During the weekday hours, ambulance service is provided by the Center Barnstead Fire Department ambulance who has full-time employees available during those hours. During night and weekend hours, ambulance service is provided by volunteers, principally from Center Barnstead and Northwood Rescue Squad as well as by private services when necessary.

Squad accomplishments during the year include an extensive revision of the by-laws, adoption of written operating procedures and presentation of two CPR courses to the residents of Epsom. In addition, squad members have been active in Emergency Medical Service district C-4 affairs, keeping the squad involved in district activities, including needs assessment, mutual aid plans, National EMS Week activities and mass casualty planning. Medical mutual aid agreements have been improved and extended with neighboring ambulance services.

Many members have upgraded their skills during the year. Members have successfully completed EMT training and recertification, EOA training, MAST training, CPR provider and instructor training and as well as participating in monthly squad training and business meeting.

Planned activities for 1986 include one or more additional community CPR courses and continued medical mutual aid and mass casualty incident planning.

The squad presently has 16 active members. Due to a very successful membership drive in August 1984, we are well staffed nights and weekends. Like most other volunteer emergency services, we are very short handed during weekday hours when the same few members available during those hours continue to provide coverage. The squad welcomes new members, expecially those who might be available during weekdays. All training and equipment is provided to members free of charge. Any interested person should contact a squad member.

Emergency medical service is available 24 hours a day by dailing 225-3355.

REPORT OF TOWN FOREST FIRE WARDEN AND STATE FOREST RANGER

Between July 1984 and June 1985, we experienced more forest fires throughout our state than in any year in the last 50. Two of the leading causes of the 1,605 fires were children and fires kindled without written permission of a Forest Fire Warden. Both causes are preventable, but only with your help.

Please help our town and state forest fire officials with forest fire prevention. Contact your Forest Fire Warden for more information.

Enforcement of a state timber harvest regulations is the responsibility of State Forestry officials. Our state has excellent timber harvest regulations; however, your assistance is needed.

If you know of a logging operation and suspect a state timber harvest law may be violated, call your Forest Fire Warden.

If you own forest land, you will become responsible for the timber tax payment starting April 1, 1986. This is a change in the Timber Tax Law that will impact all forest landowners. Contact your Board of Selectmen for timber tax forms.

EPSOM PLANNING BOARD REPORT

During 1985 the Planning Board approved 15 Subdivisions, 5 Boundary Line Adjustments, and 2 Site Plan Reviews. Meetings were held on the second and fourth Tuesdays of the month and, typically, had fewer than ten people attending, other than Planning Board members.

The amount of money collected by the Planning Board for the costs of holding Public Hearings increased this year. This reflects a reimbursement to the Secretary for her efforts in mailing and posting the required Public Notices.

The Planning Board is made up of six elected citizens who look to the future of Epsom. They do not attempt to prescribe the course our Town should take. They instead try to use the democratic processes available in Public Notices and Hearings to initiate discussion on Epsom's future needs and goals — but all too frequently are discouraged by a lack of participation or understanding of the Planning Board's duties.

The Planning Board has three main duties: 1) To subdivide land; 2) To conduct Site Plan Reviews of commercial property to assure the health and safety of the "consumer" public; and 3) To anticipate the rate and dimension of growth in Epsom so that essential services can be planned for. The first two of these functions are basic, and usually need only a straightforward application of subdivision or site plan review regulations. However, anticipating the future of Epsom is too big a job for six elected Board members. We need your comments, your criticism — your participation in the process before it is time to vote on a ballot or at Town Meeting. Please help us look to everyone's future.

EPSOM CONSERVATION COMMISSION REPORT

The Municipal Conservation Commissions work under the Enabling Statute (RSA) 36-A: 1-6, the charge is: To insure protection and proper utilization of community's natural resources and water-shed resources; research local land and water areas; coordinate unofficial environmental groups; index open space, natural, wetland, ecological or aesthetic areas and State and municipally owned lands; and provide a plan for the proper use of all these areas.

Some of the powers and duties are - to cause local review of dredge and fill projects; may accumulate funds from year to year without lapsing; may receive gifts of land, other property including funds, and lesser interests in land.

This year we viewed about 12 dredge and fill projects and made our recommendations to the Wetlands Board. We educated ourselves by attending one day workshops on Groundwater, provided by the Municipal Association. This is an area of concern for the entire country. The USGS mapping will not be completed for several years, and the local Commissions are expected to provide protection as we can through the provisions given to us in RSA 36-A; 1-6.

We agree with all of this and want very much to provide clean open areas for the future of the Town but we do not have the money available to us to protect the water-sheds against rapid growth and septage. Groundwater is not selective, and during dry seasons this may be the only recharge source for the aquifers.

We requested the Selectmen to put Five Thousand Dollars into our fund in the Budget this year as the Town's contribution to our effort to maintain the integrity of the environment. They didn't. However, we can receive donations of money and land, and would like to hear from those who believe in this cause.

This year we increased our membership from five to seven members new members include Eric Orff, Frederick Hamlett, and Michael Johnson; all well-qualified by their desire to serve the Town as Conservation Commissioners.

CONCORD REGIONAL VISITING NURSE ASSOCIATION

The Concord Regional Visiting Nurse Association, Inc. continued to service Epsom for this past year. In the Home Care Program, service is provided under a physician's plan of treatment to patients who are essentially homebound with diagnosed illness. This service is rendered by health professionals (Registered Nurses, Physical Therapist, Occupational Therapist, Speech Therapist, Nutritionist) and paraprofessionals, (Homemaker/Home Health Aides, Home Assistants) according to the patient's and family's needs. Hospice care is provided to patients in the last six months of a terminal illness. The Health Promotion Program has services (child health, family planning, screening) that are provided to low income/high risk patients and families in group settings, such as clinic and screening sites.

Health Education and Instruction is part of each home visit or clinic visit.

Anyone in Epsom may request service; patient, doctor, health facility, pastor, friend or neighbor. Patients are also referred by other agencies. All requests are answered, but continuing home care can be provided only with a physician's orders.

A call to the Concord Regional Visiting Nurse Association, Inc., (224-4093) between the hours of 8 a.m. and 7 p.m., seven days a week is all that is necessary to start services or make inquiries. Hospice staff are on call (224-4093) 7 p.m. to 8 a.m.

Federal regulations specify a charge is applicable to all visits. Fees are scaled for those unable to pay the charge if that person has no other funding source available. However, for fee scaling, federal regulations require a financial statement be completed and a fee appropriate for which the patient will be responsible. Town monies subsidize those visits that are scaled or that no fee is collectible.

This Agency is accredited by National League for Nursing and American Public Health Association Certified for Medicare and is a member agency of Home Care Association of New Hampshire, United Way of Merrimack County, and National Association for Home Care.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

"A child is a person who is going to carry on what you have started. He is going to sit where you are sitting, and when you are gone, attend to those things which you think are important. You may adopt all the policies you please, but how they are carried out depends on him. He will assume control of your cities, states, and nations. He is going to move in and take over your churches, schools, universities and corporations . . . The fate of humanity is in his hands". Abraham Lincoln

This past year saw continued growth in the number of students attending our school. Our September enrollment for the past three years indicates 318 students in 1983, 332 students in 1984, and 359 students in 1985. Enrollment projections for the years ahead indicate that we can expect similar growth for the next few years. Because of the building addition, which we occupied just four years ago, we are not yet experiencing crowded conditions. The School Board has begun to examine options of adding school space should that become necessary.

In spite of this growth, our staff presented a cohesive instructional program for students attending the school. As a result of action taken at the District Meeting in March, a part-time Art teacher was added to the staff again in September. Algebra was again taught as an elective activity, outside of regular class hours, for those students electing to take it. Standardized achievement test results indicated that our students in general were again scoring above national averages. Part of the reason for this good result is that there is a good match between our curriculum (what children are taught) and the material tested by the standardized test. Teachers spent many extra, unpaid hours working on the school's curriculum and methods of improving it.

Many parents and other interested citizens became involved in the life of the school by participation as school volunteers or as members of SCOPE, a group of citizens active in improving school-community relation. Any Epsom citizen is welcome in these important activities. For further information, call Tom Benton at 736-9331.

After several years of dedicated service as a School Board Member, Kevin Reeves resigned at the conclusion of the 1984-1985 school year. At the meeting in July, Dianna Parichand was elected, according to the provisions of New Hampshire law, to replace Kevin. More than any other person, Kevin monitored the construction of the addition to the school and devoted an enormous amount of his time to assure the district receiving full value for the money it spent on the project. Such dedication to a task is rare and Kevin's civic spirit should be called to your attention.

With the belief that "Education is a Wise Investment", I feel it important to call to your attention the salary status of our teaching staff. The district is in a less competitive position than we were just a few years ago and our teachers' salaries are falling behind a great many districts. The following figures illustrate this point:

While I recognize the limitations on our ability to pay, I also recognize that we run the risk of being unable to attract and retain competent staff unless we compensate them appropriately. I feel that we have an excellent staff who, collectively, make the school and the education of Epsom's children what it is.

PRINCIPAL'S REPORT

During the 1984-85 year we have been fortunate to have the help of many volunteers. They have helped in the areas of library, office Sun Spot (school store) and numerous projects working directly with the children. These efforts have been well coordinated by Louise Carroll. I consider this an integral part of our school program.

S.C.O.P.E. (School-Community Organized Programs for Everyone) has continued to provide programs that provide the link between the school and community. The administrative structure consists of a Steering Committee of ten Epsom citizens who meet on the second Thursday of each month. I appreciate the efforts of these individuals. Projects sponsored by this group are Game Night, Adult Education and the Scholarship program.

The new Health Curriculum includes the many health and safety programs which have been ongoing at ECS. It is an integrated curriculum and is taught through many modes. Theory is presented, as well as practical and daily living skills. It is divided into the areas of: personal care, nutrition, body systems, safety, human growth and reproduction, emotional health, substance abuse, disease prevention and health careers and consumerism.

Our present student enrollment is 365 children. We are beginning to look at space alternatives to deal with our increased student population. The Board has explored the possibility of using the basement space, building an addition to the rear of the building or an upper level addition.

Our sixth grade continues to participate in a week long environmental camp in Peterborough, New Hampshire. The curriculum taught during the year prepares the children skills from the classroom to the outdoor environment. Students have raised part of the camp tuition through a Christmas sale; in addition, the S.C.O.P.E organization plans to donate the proceeds of Game Night to the sixth grade class.

This year the Federal Block grant money has been used to create an Enrichment program for our students. CARE (Challenge Activities Reaching Epsom) is designed to provide experiences in math, reading and language, arts, drama and music.

Our part-time art program has provided classroom instruction for Readiness through grade 6. Students have enjoyed exploring various art mediums and creating their own masterpieces.

At this time I wish to thank Donna Birch, our school secretary, for all her

time and efforts spent writing school news for the Suncook Sun. This, as well as monthly newsletters, keep parents and the Epsom community well informed. In addition, I would like to thank the staff, parents, and the community for their continued support to our school.

EPSOM CENTRAL SCHOOL NURSE'S REPORT

The 1984-85 school year was a busy one. There were approximately 2900 visits to the health office. Children are seen on a "walk-in" basis for first aid, illnesses, and health counseling. Screening programs were carried on in the usual manner. Those programs include: screening for problems with hearing, vision, color perception, scoliosis, and blood pressure; physical and pediculosis inspections; and nutritional assessments. Referrals are made when necessary and follow-up care is continued if needed. The School Nurse provides nursing services to "special needs" children and is also a member of the Pupil Placement Team.

Dental care and education continued. The Dental Health Conference, sponsored by the Bureau of Dental Public Health and the newly formed S.C.O.P.E. was attended by 228 children. Each child received a cleaning and fluoride treatment by Mrs. Linda Sawyer, Dental Hygenist. Dental care was given by Dr. David Albee, Dr. David Gruette, and Dr. Douglas Johnson. This was sponsored by the Epsom Women's Club, the American Legion Women's Auxiliary, Unit No. 112, the Concord Kiwanis Club, and the School Nurse Student Health Association. The Fluoride Rinse Program, also sponsored by the Dental Bureau, was popular with the majority of our students. The program consists of dental health education, daily brushing, and a weekly fluoride rinse.

Some of our children received financial assistance for medicine, vision care and glasses, hospital visits, medical care, and clothing. They were assisted by the State Bureau of Handicaped Children and the S.N.S.H.A. which is supported by private businesses and organizations.

The school's immunization rate remains at over 99%. Children needing immunizations were taken to the Rural District Health Council Clinic. Ninety-two students participated in the "athletic physical" program conducted at the school by the Pittsfield Medical Center.

Health education programs taught or team-taught by the School Nurse included the ARC "Basic First Aid Course," Human Growth and Development, and the 8th Grade Health Awareness class which includes substance abuse prevention information, community health and health careers. The school received a "mini-grant" from the State Department of Nutrition Education and Training Program. The goals were to help develop a nutrition education program on a continum and to make a transition in the school store to sell only nutritious snacks. Both goals were met with the cooperation of all teachers, the Hot Lunch Staff, the librarian, teacher aides, parents, volunteers, and support from the community. The School Nurse coorginated the program

and Mrs. Fostier, the School Store Coordinator reports that the store is more popular than ever. The School Nurse was also chairman of the Health Curriculum Committee which worked this year on a health continum as well. The final draft is now complete.

Health programs are made possible only with the cooperation and support of many. I wish to thank the School Board, the Superintendent, the Principal, the Epsom Rescue Squad, the clubs and agencies, parents, volunteers, teachers and school staff.
