

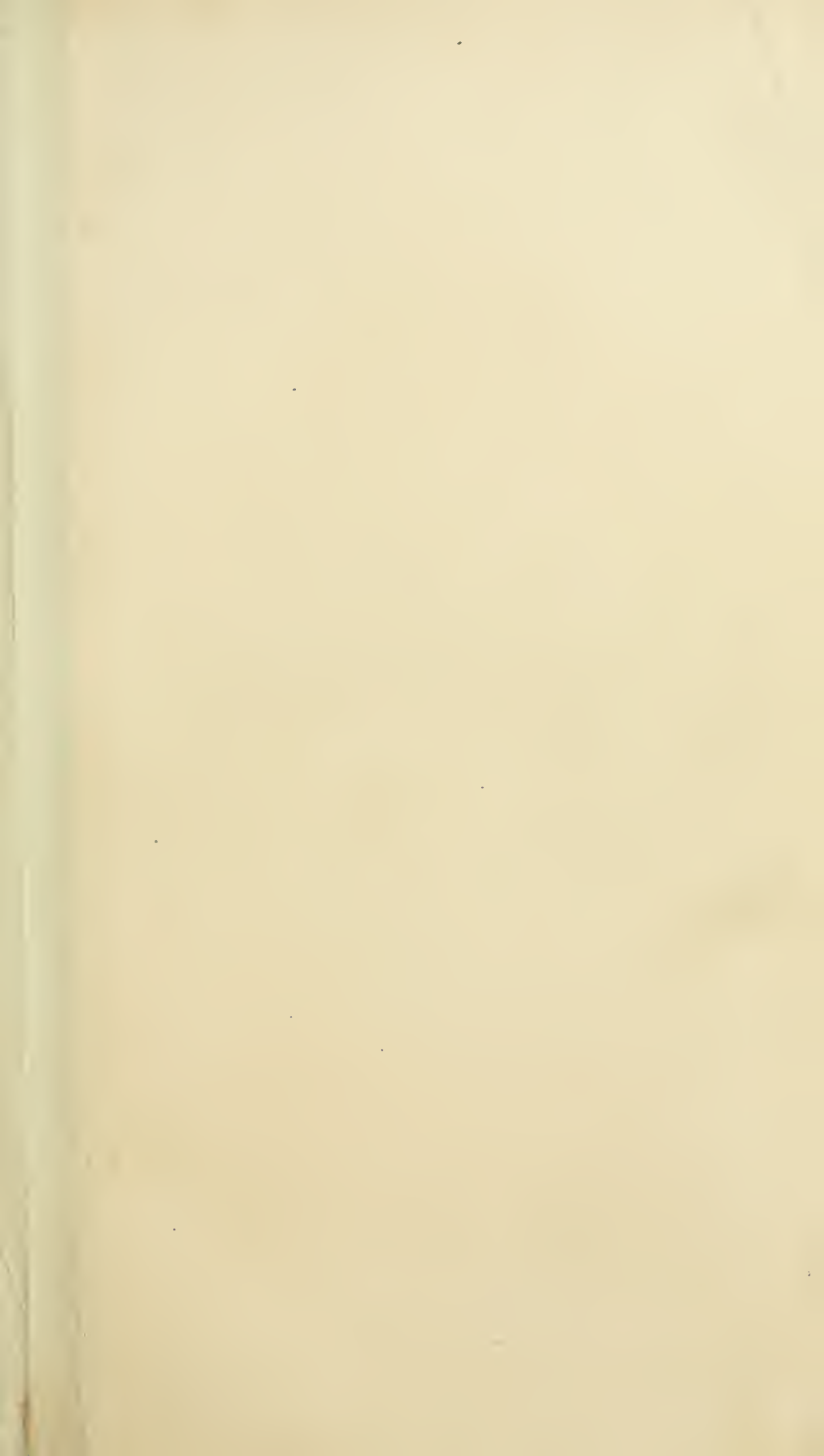

INTRODUCTION.

One hundred and seventy-six years ago the Ames family settled in that part of Exeter which is now the town of Newmarket.

Rev. J. H. Fitts, pastor of the Congregational church in South Newmarket, has kindly furnished the following facts concerning the Daniel Ames family, which he has gathered in the course of general studies in Newmarket family history. I am indebted to him for the facts furnished, and for courtesies shown when on a visit there in November, 1890, for which I return thanks.

Newmarket was a part of Exeter until 17 December, 1727. The Ames estate was about six miles from Exeter village, pleasantly situated on the north side of the Piscassic river near the corner of Hall's Mill and Lee roads. It is now owned and occupied by Smith Sanborn. Near the westerly side of a large, well cultivated field, there is a knoll which is elevated ten or fifteen feet above the rest of the field. On this knoll Daniel Ames built his log house. It had two rooms on the floor, and was two

stories in height. The upper story projected over the lower, so that the house when used as a garrison could be defended against the attacks of the Indians. Here our ancestor lived with his family, and here he died, in January, 1754.

In this field, at a bend in the river and near its bank, is another knoll, about eighty feet in diameter, which is now covered with trees. It was here that Daniel Ames and his household were buried. The neglected graves are distinctly marked by small, rough stones, upon which there are no inscriptions.

All that can be given which relates to his history are such items as may be found in the offices of the register of deeds and the register of probate for Rockingham county, which are as follows :

DANIEL AMES,

husbandman, purchased thirty acres of this homestead of the family of Joseph Hilton, 25 June, 1714. He mortgaged this messuage and the dwelling-house upon it 19 August, 1720, to William Hooke, of Salisbury; 6 September, 1731, four years after Newmarket had been set off from Exeter, Daniel Ames, freeholder, of the parish of Newmarket, sold to Richard Perryman, of Exeter, thirty acres of common lands, apportioned to him by a committee of the township of Exeter: 3 May, 1740, he sold 150 acres of land on Piscassic river to Nathaniel Ames,

his son, for "one thousand and two hundred pounds in passable Bills of Credit of y^e Province."

On 4 June, 1744, Daniel Ames received a quit-claim deed from Edward Hilton, of Hilton's "old lot," being part of the Piscassic mill grant. With his sons, Simon and Nathaniel, he conveyed to Edward Hilton, 3 June, 1746, a portion of the Piscassic mill grant. He sold to Edward Hilton, 22 November, 1747, "certain strips or points of land Joyning to y^e s^d Ames's home place."

The will of Daniel Ames, "aged and well stricken in Years, and in a weak habit of body," dated 24 December, 1753, was presented for probate 30 January, 1754. It makes his sons, Nathaniel and Jacob, executors, and gives to them the homestead. The will also mentions

Children:

- I. SIMON was witness, 3 May, 1740, to deed of land from Daniel Ames to Nathaniel Ames. He was of Canterbury as early as 1749. Will dated 14 December, 1786; presented for probate 13 May, 1793; mentions daughters, Mercy Heath, Elizabeth Gordon, and Mary Ladd, and grandson, Simon Ames Heath, who is executor.
- II. SAMUEL, witness 22 November, 1747, to a deed from Edward Hilton to Daniel Ames; was of Canterbury in 1749. His will of Canterbury, gentleman, signed 22 June, 1793, and proved 18 May, 1803, mentions wife, two daughters, Sarah Morrill and Hannar Bean, and sons, Samuel, and David who is appointed executor.

- III. DANIEL, husbandman, 15 November, 1744, received from Nathaniel Ames deed of land on Piscassic river: was of Canterbury, 1750. [See Prov. Papers, VII, 56.]
- IV. NATHANIEL bought of Daniel Ames, 3 May, 1740, 150 acres of land on Piscassic river; sold land on Piscassic river to Daniel Ames 15 November, 1744; petitioned for Newfield bridge 21 November, 1746: with David Ames he bought, 17 April, 1753, land joining the Ames possession and the mile grant line of Charles Rundlett: 25 November, 1755, Nath^l and Jacob Ames petitioned for a bridge at Newfields. On 11 December, 1758, he received of Josiah and Sarah Hilton, administrators of the estate of David Ames, a quit-claim deed of land bought of Charles Rundlett 11 April, 1753: same date, 11 December, 1758, he sold Jacob Ames ten acres of land in two pieces: this year, 1758, the name of Nathaniel Ames, Jr., appeared on records: in 1766 he was awarded damages in the laying out of Hall's Mill road: 15 April, 1775, he sold to John Burleigh "all my Farm whereon I now live, Containing Ninety acres more or less, with the buildings thereon." Nathaniel Ames, 2d, was with other Newmarket patriots in building fire rafts on the Piscataqua at Newington 22 October, 1775. On 12 July, 1776, with Nathaniel Ames, Jr., he also signed the Association Test: he sold John Ames, 28 August, 1782, "all my Farm whereon I now live, Containing Ninety acres, with the buildings thereon."
- V. JACOB, with wife Sarah, sold to her brother, James Hersey, 7 December, 1743, all their right in the estate of their "Hon^d Father, Peter Hersey," by estimation about 60 acres, within "Y^e Tract of Land Commonly Called and Known by y^e name of Moses Gilman's six hundred acre grant." On 21 November, 1746, Jacob and Nathaniel Ames petitioned for a bridge over Squamscott river. Jacob Ames bought

of Winthrop Hilton, 23 October, 1752, ten acres of land that said Hilton bought of Thomas Haley: he purchased of Daniel Lyford, 30 May, 1753, land joining his own and that of Walter Neal, on Piscassic river: 25 November, 1755, Jacob and Nathaniel Ames petitioned for a bridge at Newfield: he bought land of Nathaniel Ames 11 December, 1758, and the same year sold to Andrew Burleigh the land he had bought of Winthrop Hilton 23 October, 1752: he purchased 12 acres of land of Joseph Young 21 April, 1763. In 1766 Hall's Mill road passed through his land: he refused to sign the Association Test 12 July, 1776: d. 1806. His son, Jacob Ames, Jr., m. Mehitable Gooden 1 August, 1779. Jacob Ames was of Society Lands, Hancock, 7 September, 1779. Jacob Ames, of Newmarket, sold to James Hersey, of Sanborn-ton, 22 August, 1786, "the ten acre Lot on the Great Hill so called in Newmarket, it being the land I had by deed from Brother James Hersey of Newmarket." In 1806 Jacob Ames had died, leaving son Daniel.

VI. DAVID died 24 December, 1753, leaving widow and relict Sarah, to whom his father wills the easterly end of his house so long as she remains a widow. David Ames purchased of Richard Smith and his wife Mary, daughter of Richard Metoon, 11 December, 1749, land "att or upon a Place Call^d Smarts Cricke In New Market," and he sold the same land to Walter Weeks 9 January, 1753. With Nathaniel Ames he purchased of Charles Rundlett, 17 April, 1753, land adjoining the "Ames Possession." His interest in this purchase was sold to Nathaniel Ames in 1758, by Josiah Hilton and Sarah Hilton his wife, administrators to the estate of David Ames, deceased intestate.

VII. ANNA, wife of Powell.

VIII. LYDIA, wife of Charles Rundlett.

IX. MARY, to whom her father's will gave a legacy, and a room in the westerly end of his dwelling-house so long as she lived single.

There is a tradition that the names of the six sons of Daniel were put in rhyme as follows:

“Samuel, David, and Daniel,
Simon, Jacob, Nathaniel.”

The second son of Daniel was Samuel, who was born in Exeter, and died in Canterbury. He was the great grandfather of the compiler. The facts embodied in this compilation have been gathered from nearly all of the families mentioned therein now living, and are believed to be as correct as can be in a book of this kind. To all of the friends who have aided me I return my thanks.

This compilation has occupied much of my time for several years. I expect no other reward for my labor than a consciousness that I have done something that will be appreciated by all those living whose names appear in this genealogy.

Previous to 1752 the legal year began on the 25th of March, and the historical year began on the 1st of January. In old records these two methods were frequently combined, thus,—March 10, 1728–9, means that the year was 1728 of the legal year and 1729 of the historical year, the latter being the method now in use.

The usual abbreviations for the states are used,

appearing only once after each family name, and that where the place of residence is first given.

Names of towns, if without special designation, are supposed to be in New Hampshire. Other abbreviations are used,—as b. for born, m. for married, and d. for died.

FIRST GENERATION.

SAMUEL AMES.

1. SAMUEL was born 13 February, 1723. He came to Canterbury from that part of Exeter called Newfield (which was incorporated 17 November 1727, as the town of Newmarket), about 1749, and settled near the meeting-house at the centre of the town, on the farm recently occupied by the late Reuben Fellows. In 1791 he moved to that part of Canterbury called the "Borough," having obtained possession of a large tract of land there, upon which was an unfinished two story house. This house is now standing. The farm is owned and occupied by the family of his great-grandson, the late Dea. Lorenzo Ames.

He married Hannah Dolloff, who was born 18 January, 1728. Samuel died in Canterbury 16 January, 1803. Hannah died in Canterbury 23 Jan-

uary, 1804. They were buried in the private family lot on the farm near the Ames mansion, where properly inscribed monuments have been erected.

We insert here such information as we have in regard to Laban and Sarah Ames Morrill and their descendants.

Laban descended from Abraham Morrill, who died at Roxbury, Mass., October, 1662. His father, Ezekiel Morrill, was one of the first deacons of the Congregational church in Canterbury. He died February, 1783, aged 80 years. Two of his sons were deacons of the same church. David was elected November, 1793, and died June, 1799, aged 65.

Laban, brother of David, was elected deacon, May, 1800, and held the office until his death. He was b. in Salisbury, Mass., 25 Sept., 1740; m. Sarah, dau. of Samuel Ames, of Canterbury. Laban d. in Canterbury 12 May, 1812. Sarah d. in Canterbury 25 July, 1827.

SAMUEL AMES.

2. SAMUEL² (Samuel¹) was born 12 May, 1745. He moved to Boscawen, and became the possessor of the farm on High street known as the Ames place, where his son Joseph kept a tavern many years. He served in the war of the Revolution, at the battle of Stillwater, under Gen. Gates. We find by the records of Boscawen he was one of the selectmen in 1791. He married Jane, the only sister of Col. Henry Gerrish, who was born in Boscawen 20 April, 1745.

Samuel died in Boscawen 1 Sept., 1825. Jane died in Boscawen 30 March, 1814.

DAVID AMES.

4. David² (Samuel¹) was born in Exeter or Canterbury 27 May, 1749. He married Phebe, daughter of Thomas and Miriam Kimball Hoyt, who was born in Amesbury, Mass., 22 Nov., 1756. They lived on the farm near the meeting-house in Canterbury until 1791, when they moved to the farm in the "Borough" with his father.

David died in Canterbury 22 Sept., 1812. Phebe died in Canterbury 30 Oct., 1838.
